

# CALL FOR ENTRIES **The Student Show 2024**

July 19 - August 17, 2024 / Opening Preview on July 18, 6 - 8 pm

## Eligibility

Any student (age 16+) who has taken an Art Center class since September, 2022, may exhibit. One piece may be entered per series class or workshop taken, up to a maximum of two pieces per student. *(Please note that the same class taken multiple times with the same instructor counts as one class.)* Entries must reflect the medium and the purpose of the class taken.

## What to Enter

- All media, 2-D and 3-D, except installation and video, will be considered.
- The maximum height, width or depth per entry is 72 inches.
- Works must be original and completed since September, 2022.
- Work done under instruction must be executed solely by the student.
- Kits are not allowed.
- Work exhibited in previous Art Center shows will not be accepted.

## Entry Fee

Free for all students!

## Process

There are two inventory tags below. One tag must be completed (both halves, do not separate!) for each entry. To ensure accurate show labels for your work, please write legibly and make sure tags are easily readable. Attach the completed tag to the *hanging wire of a 2-D* piece or the *bottom of a 3-D* piece of work.

## Sales & Reproduction

The Art Center will retain a commission on all sales of work: 40% for Members, 50% for Non-members. Consent to photograph gallery installations of artwork is assumed unless specifically refused in writing.

## Requirements

- All artwork must be ready to display.
- 2-D work must be dry, framed (or gallery wrapped canvas with finished edges) and securely wired for hanging.
- 3-D work must be stable and structurally sound.
- Acetate or shrink-wrapped work will not be accepted.
- Deliver your artwork with inventory tag complete and attached.

## Liability

Work will be insured by the Minnetonka Center for the Arts from the time of intake through pick up.

## INTAKE

Deliver work *(see Requirements)* to the Laura H. Miles Gallery Thursday, July 11, 6 -8 p.m. and Friday, July 12, 9 a.m. - 12 p.m.

## PICKUP

Pickup your artwork on Tuesday, August 20, 3 - 7 p.m.
